Key Points When Considering AI for Your Business:

- AI loves systems! Systematize your workflows and processes before you start trying to use or implement AI. AI needs strict confines and boundaries to produce usable work product and your first hurdle is to build that structure and foundation to let AI do the work for you. Take your time to really understand and find the right workflow for you.
- Start with low hanging fruit. I know you see how I am using AI for contract reviews already but I started with automating low level tasks years ago from scripting and automating client file creation and engagement letters. You would be surprised how 5-10 minutes a day adds up in a year which can be freed with existing (and free!) technology on your current PC or phone.

- You do not need to be a programmer or an expert in AI to utilize it, but you need to be an expert in your workflow, system, and the desired output. You can hire experts to get you to using AI but you need to be able to explain your workflow, the desired output, and how you get there in your current system. Then let them take it and run with AI.
- AI is here to stay, it may not replace you in your job but anyone who is not starting to learn and use AI now will be irrelevant and left behind in the next 5-10 years. Good news is that your interest in AI and checking out our webinar already puts you ahead of the curve!
- Very few high level tasks, such as legal work, will ever be AI-only. Man or Machine will always have some percentage of error in their work product but with Man+Machine we can get very close to eliminating errors in daily work products.
- It is not as hard as you think to get started. I spent a year trying to develop a system on my own (costs were higher just a couple years ago and not feasible) but ultimately the amount of work and time to get something halfway usable was not cost effective. The progress in just the last 2 years have been astounding in regards to the cost effectiveness and the user interface (usability) of AI systems. We are at the cusp of wide scale adoption and becoming very accessible to anyone.
